Overview

The collection, disposal and recycling of WEEE waste is part of a wider NOE CPC Framework for Waste Disposal and Recycling Services. This information sheet is to highlight the lots contained within the framework agreement that are specific to WEEE waste lots 6 and 7.

The agreement is available to trusts in the Yorkshire and Humber region and has available a number of suppliers accredited to handle WEEE waste.



Comprehensive WEEE waste services

A broad range of WEEE waste can be handled under this agreement including:

Cat 1 – large household appliances i.e. refrigerators, freezers

Cat 2 – small household appliances i.e. vacuum cleaners, toasters

Cat 3 – IT and telecommunications equipment i.e. mainframes, printers, personal computers, fax machines, telephones

Cat 4 – consumer equipment i.e. radios, TV sets, video cameras

Cat 5 – lighting equipment i.e. fluorescent lamps, sodium lamps

Cat 6 – electrical and electronic tools i.e. drills, sewing machines, welding tools

Cat 7 – toys and leisure sports equipment i.e. electric trains, video games, electronic sports equipment

Cat 8 – medical devices i.e. cardiology, dialysis, radiology, analysers

Cat 9 – monitoring and control instruments i.e. smoke detectors, heat regulators, thermostats

Cat 10 – automatic dispensers i.e. dispensers for drinks, solid products, money

Cat 11 – display equipment i.e. monitor screens

Cat 12 – cooling appliances i.e. appliances containing refrigerants

Cat 13 – gas discharge lamps

The agreement supports trusts to ensure that the government targets for reuse/recycling this type of waste are met or exceeded and offers the option for bulk rates and unit rates for the collection of different types of WEEE waste.

Furthermore, the agreement offers the flexibility to handle varying volumes of waste with container and collection options to meet fluctuations in demand.

This agreement is the output of a competitive tender process, and offers access to competitive commercial terms either by direct "call off" or through undertaking a further "mini competition."

Audit and tracking of your WEEE waste

Enables trusts to operate robust tracking of their waste activities to ensure Duty of Care requirements are met.

Contract management

By using this agreement organisations can benefit from the support of NOE CPC throughout the life of this contract.

Framework tools

A guidance document covering details of how to conduct further competitions including a matrix of suppliers awarded to particular Lots, together with a pricing summary matrix and draw down agreement template, is available on our website.

Impacting on cost

This agreement is the output of a competitive tender (OJEU) process, and can be further competed by conducting mini competitions. The focus on recycling and reusing impacts on the total cost by reducing the impact on landfill and associated costs, and in some cases enables a return on resale items.

Environmental impact

A key consideration when undertaking the procurement of the agreement was to minimise the environmental impact.

This is achieved by maximising the reuse/recycling of the materials generated from WEEE waste. Where IT equipment is reused data removal compliant with HMG 1A (formally Infosec) Standard 5 is utilised and a rebate returned to trusts where such items are eligible for resale.

The framework requires WEEE waste not to be exported to developing countries unless where strictly controlled within the regulations governing such export.

Regulatory compliance

This agreement ensures a fully traceable and auditable Chain of Custody for all WEEE related waste.

The agreement is compliant with the following:

- Environmental & Waste (eg. Waste Management Licensing Regs)
- Transport
- Health & Safety (eg COSHH)
- Relevant HTM requirements
- WEEE Directive
