Procurement leaders in NHS provider organisations are increasingly finding themselves having to juggle conflicting priorities. The Health & Care Bill, published in July, sets out the intention to create statutory Integrated Care Systems (ICS) and includes further tools to enable integration of health and care services. The ICS Design Framework, published on 16 June 2021, states that a specific function of each ICS will be "Driving joint work on estates, procurement, supply chain and commercial strategies to maximise value for money across the system and support wider goals of development and sustainability". As part of its ICS Based Procurement Guidance, NHSEI sets out 34 activities with the aim to measure ICS procurement maturity, and ICSs are now being asked to report on their progress against these every month.

With pressure coming from all sides, including significant supply chain challenges, pricing issues, PTOM, uncertainty over the future of the Public Contracts Regulations, the delivery of sustainability, local savings targets, and not forgetting day-to-day operational delivery, all in the wake of a pandemic, how do we prioritise where to focus our efforts?

The Round Table will explore how all the above may impact on procurement leaders and their teams, and reflect on how procurement can continue to contribute to achieving improved value, whilst balancing all the conflicting pressures which currently face the profession.
