#### **Background to contract**

The Bariatric Furniture and Equipment Framework is the first framework agreement of its type to draw together a wide range of specialist bariatric products. The specification was developed by the Bariatric Stakeholder Group, made up of specialists from many fields including Acute, Community, Mental Health, Ambulance Services and Local Authorities. The representatives came from a range of specialisms, including Hazardous Response Teams, Manual Handling, Tissue Viability, Equipment Specialists, Mental Health Services, Health and Safety, Mortuaries and Dieticians.

This is the first framework put together by the East of England NHS Collaborative Procurement Hub which has the potential to be accessed by other public sector bodies, such as Local Authorities and Fire Services, who all work with the NHS to care for this group of patients.

This agreement is the output of an initiative by East of England NHS Collaborative Procurement Hub. The agreement is open to all trusts served by the NHS Collaborative Procurement Partnership (CPP), which is a strategic partnership between NOE CPC, East of England Collaborative Procurement Hub, NHS Commercial Solutions and NHS London Procurement Partnership.

The framework allows the option to directly award to appointed suppliers or undertake a further competition.

### What does it cover?

The following categories are included in the framework agreement:

- Beds and Mattresses
- Chairs
- Wheelchairs
- Patient Transfer
- Specialist Hoists and Slings
- Ramps
- Aids to Daily Living.

The framework covers rental and purchase of bariatric items and includes packages for rental which can be tailored to requirements.

There is also a bariatric total product listing which forms a catalogue of products for the framework.

### **Benefits**

This framework agreement has the potential for Trusts to benefit from framework pricing and discounts as highlighted by each supplier.

There is also an option for further competition, with the potential to realise further savings against specific requirements.
